The Government of
Saskatchewan recently
announced a new Minister for
Seniors for Saskatchewan.
The Honourable Warren Kaeding,
member for Melville-Saltcoats,
was elected to the Legislative
Assembly of Saskatchewan in the
2016. He is also the Minister for
Rural and Remote Health.

The SRA, working with our partners at the Saskatchewan Seniors Mechanism (SSM) are encouraged by the appointment as there have been efforts over several years to seek more focused attention to the interests and needs of older adults in the province.

With a growing population of older adults in Saskatchewan, we encourage the Minister to consider the "Saskatchewan advantage" of the large number of older adults, as we bring experience, skills and a wealth of knowledge that is available and ready to be accessed for all sorts of future opportunities.

## FEDERAL GOVERNMENT: PENSION CHANGES

The SRA Pensions and Issues Committee has been monitoring changes to Canadian Pension Policy for Advanced Life Deferred Annuities (ALDA) and voluntary pooled or share risk pension opportunities through Variable Payment Life Annuities (VPLA). Recent changes in Federal legislation have made positive changes to both these options. These changes will provide Defined Contribution (DC) Pension holders ("new plan") with greater flexibility for ensuring a steady income stream as long as may be needed.

The Committee has spent time researching these issues and provided a resolution to Saskatchewan Seniors Mechanism (SSM) in support of these initiatives at their 2019 annual meeting.

#### BE IT RESOLVED

That the Saskatchewan Seniors Mechanism contact the Federal Government to urge changes in Federal legislation immediately to allow retirees who are enrolled in Defined Contribution Pension Plans to have more options for their plans such as Pooled Risk Pensions or Deferred Life Annuities.

Pooled Risk Pensions through a VPLA will allow pensioners to pool their pension holdings with others to also ensure a consistent stream of income for as long as may be required.

Changes to ALDA will increase the age of starting these annuities from age 71 to age 85 years. This will allow pensioners to purchase annuities later in life that would ensure recipients with a constant stream of income till death.

Each province needs to adopt these changes to make them available to older adults. The SRA Pension and Issues Committee will be continuing to pursue these issue in efforts to ensure these options will be made available to Saskatchewan Government DC Pension holders should they decided to choose these options.

# SASKATCHEWAN'S ADVANTAGE!

Saskatchewan's population is projected to grow over the next 25 years, and one part of that growth will be in the population of older adults. According to Statistics Canada (2016 census), the percentage of people over the age of 65 years in Saskatchewan is projected to increase from 14.4% to about 23% by 2038. The SRA provided financial support to Saskatchewan Seniors Mechanism (SSM) to assist in the completion of a major research project to help identify the interests and needs of older adults. Over 45% of the respondents to a survey completed last spring were SRA members so your voices will be part of the results of the research when its released later this fall.

Saskatchewan relies on older adults for a variety of important roles that ensure our families and communities continue to be productive and energized. In the SSM survey, 71% of respondents indicated that they were volunteering up to ten hours per week with their family and in their communities. Older adults are also very involved in caregiving, often providing inter-generational care to others. 23% of the survey respondents indicated that they were actively providing care to family or friends. Many caregivers were providing at least 5 hours weekly to support family members or others in their communities.

These forms of unpaid work form part of an "advantage" that Saskatchewan has and is being recognized more fully than in the past. At the SRA, we have begun to recognize the lifetime contributions through our honorary lifetime member awards. So if you know one of our members that should be considered for his/her achievements, please let us know.

We also continue to look to our members to use your skills to help our Committees and Board of Directors. Each year, at the Annual General Meeting, we have terms as directors open for our members. With our member engagement activity, we also are looking for local contacts that may want to host an activity in your region of Saskatchewan.
