### **CHANGES COMING TO YOUR HEALTH AND DENTAL PLANS**

The Saskatchewan Retirees Association (SRA) has been working closely with GMS to explore potential enhancements to our Health and Dental plans. After a thorough review, we concluded that our current plan already provides excellent benefits. As a result, no major changes will be made to the basic types of coverage currently available. We are starting to respond to your feedback and will begin to offer greater flexibility and expanded options for members. Some of the enhancements include:

- Increased drug and dental maximums Members may soon have options to raise coverage levels at a reasonable additional cost.
- Extended travel coverage We will be increasing lifetime coverage from \$1 million to \$5 million and are exploring the possibility of adding extra travel

days beyond the existing 60-day limit. While the extended day enhancement may take more time to implement, we expect to have it available in time for the winter travel season.

In addition, we are pleased to announce that SRA has renewed a **five-year agreement with GMS**, ensuring continued stability and high-quality service for our members. This long-term partnership will also allow us to explore further enhancements in the years ahead. The new agreement will support changes GMS is making to improve member services and response times.

More details on the upcoming changes, including specific details and premium rate changes for the 2025-26 policy year, will be outlined in our renewal letter this May. Stay tuned for further updates!

### **SRA LEGACY SCHOLARSHIP PROGRAM**

## WHAT IS THE SRA LEGACY SCHOLARSHIP PROGRAM?

The Saskatchewan Retirees Association (SRA) is proud to celebrate a major milestone—our 50th Anniversary! Since 1975, SRA has been a strong advocate for retirees from Government of Saskatchewan ministries, Crown corporations, and agencies. Over the years, our mission has expanded to include administering a group Health and Dental Benefits plan and providing valuable learning opportunities for our 4,400+ members.

The Legacy Scholarship Program reflects SRA's ongoing commitment to retirees and their families, fostering education, and strengthening our community. By investing in students who are dedicated to improving senior care, we are ensuring a lasting impact that extends well beyond this milestone year. This initiative represents a \$75,000 investment in education and innovation in senior care.

#### HOW DOES IT WORK?

Fifteen scholarships, each valued at \$5,000, will be awarded to students attending:

- University of Regina
- University of Saskatchewan
- Saskatchewan Polytechnic

Application intake begins June 1, 2025, for the Fall 2025 semester.

### HOW TO APPLY

To be eligible, students must verify their family connection to an SRA member as of December 31, 2024. This can be completed by visiting our website:

saskretirees.org/members/scholarshipverification-form Once verified, students will receive a letter of eligibility to submit their application to their chosen institution.

The SRA Board of Directors encourages all eligible students to apply and wishes them success in their studies and future endeavours!



### **SRA'S ADVOCACY FOR PENSIONS**

The SRA continues to work with Plannera to build a strong relationship that can benefit both SRA and Plannera members.

#### **RETIREE REPRESENTATION ON THE PEPP BOARD**

Retiree membership in the Public Employees Pension Plan (PEPP) has been growing steadily since 2006, when the Variable Pension Benefit (VPB) was introduced, and retirees were first given the option to remain invested in the Plan and withdraw retirement income from it. The SRA presented the case for retiree representation to PEPP and Plannera representatives. For those who are interested, more information about this important issue can be found on the SRA website.

The PEPP is introducing Lifetime Pension, a new retirement income option designed for retired PEPP members aged 50 to 94. Launching in April 2025, this option ensures members receive guaranteed monthly income for life, providing financial security in retirement.
