## SRA CAN HELP!

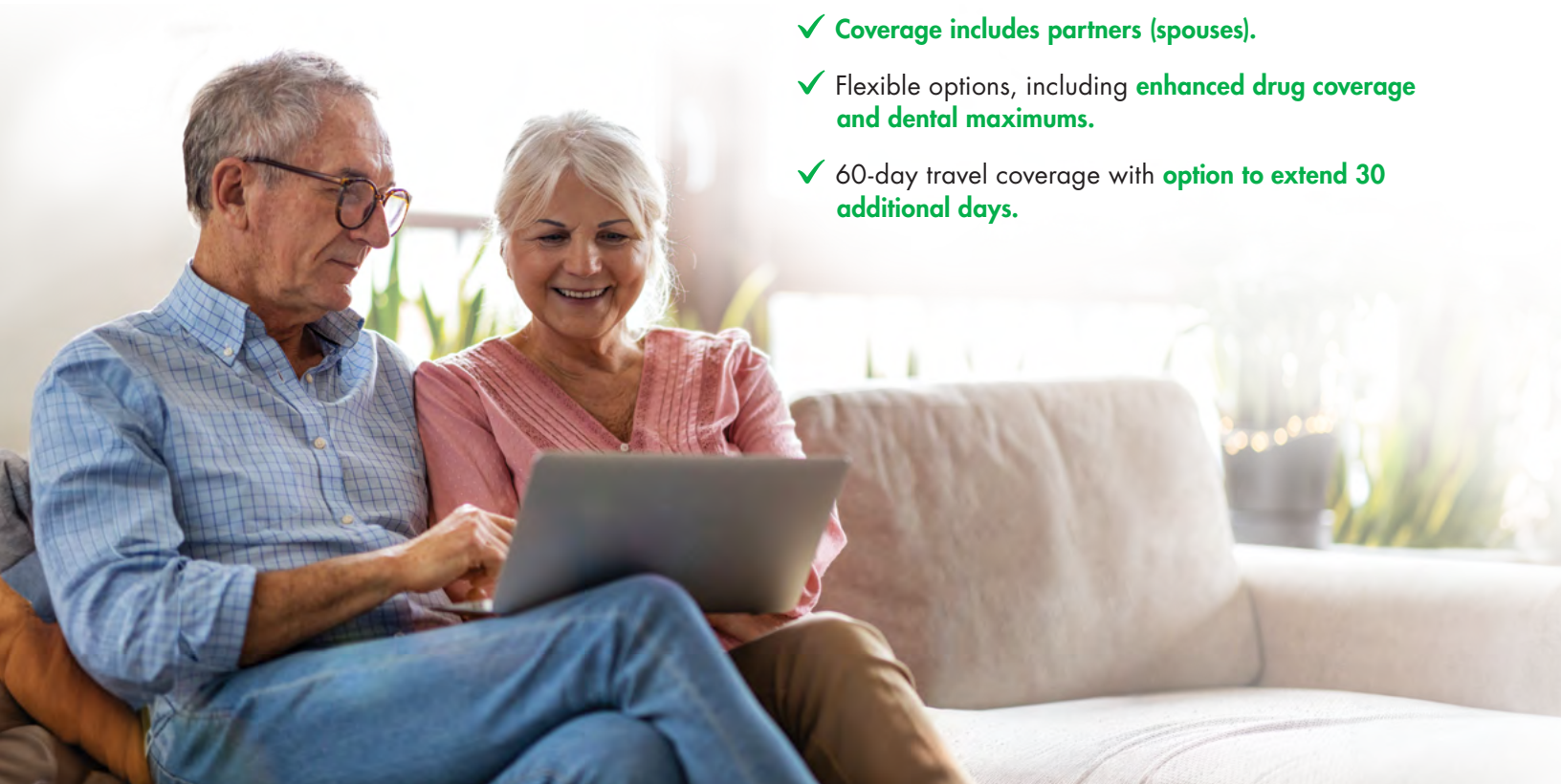
